#### **Summary of the Conformity Assessment Requirements**

#### **Conformity Assessment Results**

The conformity assessment target meets the criteria set forth by the standards and regulations indicated before when implemented under the reviewed Terms and Conditions and following the recommendations provided for the ongoing service certification. The identification service policy includes limitations to the service.

The conformity assessment target is the remote video identification service component provided by Onfido. When correctly implemented by a qualified trust service provider issuing qualified certificates, it can be used to issue qualified certificates with QCP-n and QCP-n-qscd policies.

This remote identification service provides equivalent assurance to physical presence as it complies with the requirements for a substantial level of assurance according to Commission Implementing Regulation (EU) 2015/1502 and the requirements set forth by regulation implemented at a national level by the Romanian eIDAS Supervisory Body.

#### **Conformity Assessment Target**

Onfido's remote identification service is a trust service component for issuing qualified electronic certificates for electronic signatures, compliant with QCP-n and QCP-n-qscd policies.

The scope includes Onfido's distributing partners: Onfido BV (Netherlands), Onfido GmbH (Germany), Onfido PTE Ltd. (Singapore), Onfido SAS (France), Onfido Inc. (Delaware, USA), and Onfido Services India Private Limited (India).
